>I'm running two 17" flat screens on my G4. The DVI will give you better
quality into a DVI equipped monitor, but for PARIS, it won't make much
difference. You'd only notice a dramatic difference if you were working with
really high resolution graphics, etc. My advice would be to go with two 17"
or 19" monitors (the bigger the better) and use a DVI to VGA adaptor if
needed. It will be more total screen area than one 20". Also, check the
specs on the monitors and look for a high contrast ratio, 500:1 or higher,
pixel pitch (.264 is better than .297), and response time (faster is
better). I'm sure you know all that already. Sorry to ramble.

but just like a Neve console changes the sound but in a good way, and a C12 mic sounds different than the sound in the room, but in a good way, and just about every tool in the studio that I like is a tool of change as opposed to a tool of accuracy, I think that most of the artifacts and distortions that come from tape are musical.

I also like that fact that you can use technique to shape the effect, but you never know exactly what you are going to get without listening back.

All this uncertainty gives me a warm and fuzzy feeling. Kind of like a drummer compared to a drum machine.

Keep in mind that I am a VERY early digital audio user and promoter going back before the CD was even a standard, and I do love digital for what it can do.

Legal expenses will probably far outweigh any benefits that accrue to those who participate in the action. In the event that ID ceases to issue Pace authorization codes then I am sure the small (and shrinking) user community will find alternative means of using the product; perhaps requiring the use of third-party software solutions. The use of such software will be viewed indifferently by the courts considering the authors, by virtue of their own indifference, have not seen fit to provide a viable means of using the product in the prescribed fashion and therefore will have abrogated their rights to seeking remedies against those who seemingly have violated the author's copyright. In other words, this problem will, in time, take care of itself.

I sense that ID will continue to provide Pace authorization codes as long as the company remains operational.
