I just checked, and you can use the high-pass filter in the stock paris eq to filter out the dc offset. It has to be after the effect. Placing an eq before the crossover doesn't help. I think it's probably best to use the stock eqs instead of embedding another eq in the effect if only to conserve DSP resources. The stock EQs use different, reserved chips, whereas if I embed the eq in the effect, it will take up the more scarce effect dsp.

Let me know what you think, though. I can add another eq if the consensus is that we should go that way.

A couple of other things to add to this is the Apple Lisa had ethernet and a mouse, both created at Xerox PARC. Jobs wasn't just kicked off the Lisa project, he was also kicked off the Macintosh project around 1985.
